Annual Report: 2007-2008

Highlights of My Sister's House 2007-2008 fiscal year (July 1, 2007 - June 30, 2008)

- Provided 1920 nights of shelter, utilities, food, and case management services to 40 Asian/Pacific Islander women and children fleeing abuse.
- Assisted 481 recorded callers this year, an increase of 17% from the previous year.
- Provided the Women to Work Program for 75+ survivors of domestic violence to help them rebuild their lives financially.
- Through a partnership with the Asian Bar Association of Sacramento, provided legal assistance to more than 20 Women to Work clients.
- Gave certificates of completion to 16 new shelter advocates. Four high school students were include for the first time.
- Held 4th annual Run for a Safe Haven for which more than 720 people took a stand against domestic violence.

- Hosted 5th Cultural Competencies Training Conference for lawyers.
 More than 60 lawyers, law students, and other advocates attended.
- Provided more than
 25 presentations, including a special training for
 40 religious leaders.
- Participated in more than a dozen community fairs, and reached out to more than 4850 individuals with information to help prevent domestic violence.
- Aided more than 14 mothers and 41children with mental health support sessions.
- Provided a special legal workshop for Hmong, Vietnamese, Chinese, and Filipino women.
