Annual Report: 2010-2011

Highlights of My Sister's House 2010-2011 fiscal year

- Provided 1,952 nights of shelter, utilities, food, and case management services to 127 clients largely Asian Pacific Islander and other women and children fleeing abuse.
- Helped with safety planning and information to over 700 crisis line phone calls, a 28% increase over the previous year.
- Assisted more than 100 women in our Women to Work Program from Sacramento and Yolo.
- Gave certificates of completion to 44 new shelter advocates.
- Held the 7th annual Run for a Safe Haven for which more than 800 people took steps toward ending domesticviolence.

- Celebrated our 10th Anniversary "One Night Only Gala" with more than 600 supporters.
- Provided more than 40 presentations regarding domestic violence and human trafficking, and participated in more than two dozen community fairs, educating more than 5,400.
- Provided mental health support and services to domestic violence survivors and their children.
- Coupled more than 12 legal volunteers with more than 100 domestic violence victims, assisting with restraining orders, child custody, immigration and other issues.
- Began outreach to local affordable housing complexes.
- Received the Congressional Victim Rights
 Caucus Allied Partner
 Professional Award.
