Annual Report: 2009-2010

Highlights of My Sister's House 2009-2010 fiscal year

- Provided 2109 nights of shelter, utilities, food, and case management services to 24 largely Asian Pacific Islander and other women and children fleeing abuse.
- Helped with safety planning and information to over 500 crisis line phone calls, a 9% increase over the previous year.
- Assisted more than 200 women in our Women to Work Program in Sacramento and Yolo County.
- Gave certificates of completion to 18 new shelter advocates.
- Held the 6th annual Run for a Safe Haven for which more than 700 people took a stand against domestic violence.

- Celebrated our 9th Anniversary at the Heroes of Hope Dinner with 400 supporters.
- Provided more than 50 presentations regarding domestic violence and human trafficking, and participated in more than 2 dozen community fairs, educating more than 4740 individuals.
- Provided mental health support and services to domestic violence survivors and their children.
- Provided more than 150 legal consultations with domestic violence victims, assisting with restraining orders, child custody, immigration and other issues.
- Awarded national recognition, Great Food and Shelter Program.
- One of only 46 organizations to receive grant to provide culturally and language specific services grant.
