
My Sister's House Offers a Safe Haven for Survivors of Abuse

The holidays may be over, but the season's spirit of generosity and helping those in need can be found year round at My Sister's House. This non-profit organization is dedicated to assisting Asian, Pacific Islander and other underrepresented women and children who have survived domestic violence, sexual assault and human trafficking.

My Sister's House has been active since 2000 and has been offering services such as a 24-hour helpline, a safe haven shelter, counseling sessions, classes

Vietnam War. In captivity, McCain endured torture and even turned down a chance to be released early, denying the North Vietnamese military a propaganda victory.

Bush died in November at age 94, just months after the death of his wife, former first lady Barbara Bush, who died in April. McCain died in August at the age of 81 after a battle with brain cancer.

Their deaths prompted an outpouring of public mourning from across the political spectrum that was at odds with a recent political climate that has been defined by intense partisanship, coarse insults and divisive rhetoric.

The year also saw the death of one of the world's best-known singers, Aretha Franklin. The Queen of Soul's death in August prompted a grand send-off during a week of mourning in her hometown of Detroit,

Final Goodbye: Roll Call of Some of Who Died in 2018

In a year filled with heightened political vitriol, two deaths brought the nation together to remember men who represented a seemingly bygone era of U.S. politics.

George H.W. Bush was a president, vice president, congressman, CIA director and Navy pilot during World War II, where he flew 58 missions and was shot down over the Pacific. As a politician, he had his fair share of critics and was voted out of office after one term as president. But the Republican reinvented himself in the years after his time in the White House, becoming a fundraiser for disaster relief and forming an unlikely friendship with the man who ousted him from office, former President Bill Clinton.

John McCain was a political giant in his own right. He served as a senator for more than 30 years, ran for president twice and spent five years as a prisoner of war after being shot down during the

'Border Wall': Immigration Dominated Headlines in 2018

NEW YORK (AP) – Children torn from their parents, refugees turned away, tear gas fired on asylum-seekers, and a president who says he's making good on promises to protect the nation's

borders. In a breathless 2018, they were just a handful of headlines on immigration, one of the year's most dominant issues.

Combined with a relentless stream of administrative memos and changes in regulation and enforcement, it represented a government bombardment on virtually

every type of immigration – a bold follow-up to the opening salvo of President Donald Trump's first year in office.

For those who champion Trump and believe that cracking down on immigration translates to better lives for Americans, it has been a year of fulfillment of campaign promises. For those who've watched in horror, it harkened back to other points in the country's history, when fear of new arrivals led the U.S. to refuse entry to various groups and when open discrimination of certain eth-

Ask The Old Farmer's Almanac *By Robert B. Thomas*

Prepare Your Garden Now for Springtime

Q. We've just moved into our brand-new house, and the ground is completely bare. Are there any landscaping chores that we can begin now?

A. The primary one would be the lawn. Now is a good time to start a new lawn or repair an old one. Since your house is new, you may need to bring in good topsoil to cover the builder's gravel. Existing weeds, fallen leaves, or other debris can be shredded and composted to help build up an enriched base. Plan where you'll want garden beds, ground covers, or shrubbery. If you've got time, start a bed with some spring-flowering bulbs and cover with mulch.

Shrubs such as lilacs, doghobble, and virtually all evergreens can be planted now, if you've got good soil ready for them. Consider your roofline and don't place shrubs where heavy snowfalls or spring rain runoff will damage them. Plan ahead, too, so that windows, electric or phone lines, oil or gas refills, or meter readings won't be blocked when the plants reach full size.

If you know you'll be planting fruit trees in the spring, you might consider digging the holes now, to get an earlier start on the growing season. Fill the holes with mulch and cover, to keep it from freezing too solidly. You can also dig trenches for berries and vines. Now all you have to do is request the gardening catalogs and wait for warm weather!

THIS WEEK IN HISTORY

Jan. 4, 1785, the older of the two Grimm brothers, Jacob, is born in Hanau, Germany. His brother Wilhelm is born the following year. As young men, the brothers published "Children's and Household Tales," later known as "Grimm's Fairy Tales," in several volumes between 1812 and 1822. Dec. 31, 1879, in the first public demonstration of his incandescent light bulb, American inventor Thomas Alva Edison lights up a street in Menlo Park, N.J. The Pennsylvania Railroad Company ran special trains to Menlo Park in response to public enthusiasm over the event. Jan. 5, 1933, construction begins on the Golden Gate Bridge, as workers began excavating 3.25 million cubic feet of dirt for the structure's huge anchorages. The bridge officially opened on May 27, 1937, the longest bridge span in the world at the time. Jan. 1, 1942, President Franklin D. Roosevelt and British Prime Minister Winston Churchill issue a declaration, signed by representatives of 26 countries, called the United Nations. The signatories vowed to create an international postwar peacekeeping organization. Jan. 2, 1962, an appearance by The Weavers on NBC's "The Jack Paar Show" is canceled when band members refuse to sign an oath of political loyalty. The folk group saw their careers nearly destroyed by the anti-communist Red Scare of the early 1950s. Jan. 6, 1975, some members of a large crowd in line to buy tickets to the rock band Led Zeppelin break into the Boston Garden arena and cause \$50,000 in damage. In response, Boston's mayor Kevin H. White bans the band from Boston for five years. Jan. 3, 1987, the Rock and Roll Hall of Fame admits its first female artist, Aretha Franklin. Since then female inductees have included The Supremes, Janis Joplin and The Shirelles.

nicities prevailed.

"This is our generation's sort of existential moment," said Frank Sharry, head of pro-immigration group America's Voice. "Are we going to continue to be a nation that practices 'e pluribus unum' and welcomes people from around the world to make this country better? Or are we going to shut the door?"

Throughout 2018, the answer has largely been the latter.

Even as roundups and deportations persist in targeting those who enter the U.S. illegally, the Trump administration has pushed beyond that to redefine what legal immigration looks like, too. It has slowed down or altogether halted many seeking to come to the country for a job offer or through their relationship to a citizen, and narrowed the chances of finding a home here as a refugee or asylum seeker. Jarring visuals of children in detention centers and other enforcement actions have dissuaded some from seeking to come here at all.

"There has been this constant chip, chip, chipping away at the legal immigration system using every tool of the executive branch," said Doug Rand, who worked in the Obama administration before helping found Boundless Immigration, which helps people navigate the immigration system.

The year ended with the administration saying those seeking asylum would be forced to wait in Mexico, a major shift that immediately spurred questions of

legality from opponents. Meantime, the government shutdown persisted as Trump and Democrats once again butted heads over funding to build a wall along the border with Mexico.

Even without it, though, the policies he's pursued have effectively put up a virtual wall.

"That is far more effective than a border wall ever would be," said Sarah Pierce, a policy analyst with the nonpartisan Migration Policy Institute.

Even top-tier computer programmers, architects, engineers and other professionals with job offers in the U.S. saw their applications for H1-B visas under much more scrutiny; a means of expediting processing of those visas was ended under Trump, and bids for work authorization have been met by what employers and immigration attorneys say seem like endless requests for evidence to prove seemingly straightforward facts.

Still, the odds of those professionals eventually gaining clearance to enter the U.S. are better than for many others.

Trump's so-called "travel ban," the first iteration of which was unveiled in the president's first week in office, was upheld in June by the U.S. Supreme Court, stopping most visas for residents of mostly Muslim Libya, Iran, Somalia, Syria and Yemen, as well as North Korea and Venezuela. Though the policy allows for waivers, initial data showed few such applications were actually approved, effectively shutting the door to most from those nations.

It's had very real consequences for people like Soolmaz Dadgari, an Iranian who came to the U.S. in 2017 so her 4-year-old daughter, Arina, could take part in an

experimental study to treat a rare genetic disorder. Dadgari's husband has been unable to get a visa to join them, and sanctions make it hard for him to send money. She alone cares for a child who can't walk or talk and requires 24-hour help, as well as another 11-year-old daughter.

Dadgari has considered returning home but knows she needs to remain for her daughter's treatment. Still, the situation has affected the way she views the U.S., which she had always regarded as the best place in the world.

"I have no hope," she said.

Even as wars, persecution and famine have continued around the world, the U.S. capped refugee admissions at 45,000 for the fiscal year that ended Sept. 30, the lowest ceiling since the State Department began tracking the figure in 1980. Far fewer were actually admitted in that time frame: about 21,000 refugees. The number is likely to fall further, with the cap for the current fiscal year set at 30,000.

Meantime, tens of thousands fleeing violence in Central America sought asylum in the U.S. this year. The Trump administration responded by narrowing who is eligible, declaring that neither those escaping gang violence or domestic abuse nor those who cross the border illegally qualify. Both changes have been blocked by federal courts.

Some seeking refuge in the U.S. are stuck in untenable positions.

Ivis Munoz, 26, decided to join a caravan leaving Honduras in mid-October. A gang member had shot him in the thigh and threatened to kill him. Munoz planned to seek asylum in the U.S. but learned along his journey that he was unlikely to be

accepted.

His first night in Tijuana, Mexico, he slept on the beach until rocks rained down on him and other migrants and a man shouted in the darkness: "Go back to your country!" Now he's a few hours east in Mexicali, his aching leg full of bullet fragments, overwhelmed and scared by his reality.

"I don't know what to do," said Munoz, a coffee farmer from the Honduran town of Atima. "I want to go to the United States, though I'm scared they'll send me back. I'm afraid to be in Honduras, but I don't feel safe here either."

At every turn, there were policy changes. One proposed rule would restrict visas or legal permanent residence for those receiving certain government benefits for low-income people, such as food stamps. Hundreds of immigrant enlistees in the Army were discharged or had their contracts cancelled, though some were later reinstated. Even some U.S. citizens were targeted by a "denaturalization task force" looking for naturalized Americans with past infractions.

More than any other shifts in policy, the Trump administration's move to separate apprehended migrant children from their parents shook people around the world. Though Trump eventually ended widespread use of the practice, the scars remain for those affected.

Evelin Roxana Meyer of La Union, Honduras, thought 2018 would be the year things turned around for her family. They've struggled to pay off a loan for the grocery store they run out of their home, so her husband, Douglas, and son, Eduardo, set off for the United States in hopes of finding work. Instead,

and support groups to many who have experienced domestic abuse and sexual assault. The organization also strives to educate the public about the effects of these

and assist women and children within Sacramento's Pacific Islander and Asian community, the group does not discriminate because of gender or ethnicity.

"We have helped and will continue to help survivors of all ethnicities from day one of our operations," said Nilda Valmores, executive director for My Sister's House. "Unfortunately, domestic violence does not discriminate because of gender or ethnicity. However, it is often very difficult for communities with language and culture barriers to access help."

One way that My Sister's House supports survivors of abuse and trafficking is through the efforts of My Sister's Cafe, a volunteer-based program that helps them to get back on their feet financially with the goal of becoming self-sufficient. Located on Capitol Mall, it is the only cafe operated by a domestic violence shelter amongst California's many domestic vio-

lence shelters. It serves breakfast, lunch and afternoon snacks, does deliveries for groups of 10 or more and is also available to be booked for special events.

"My Sister's Cafe was established to enable our clients to live their life free of abuse," Valmores explained. "It also provides volunteer opportunities and serves as a new source of revenue to finance the organization's services and ongoing commitment towards helping victims of domestic violence, sexual assault and human trafficking."

In addition to providing employment through My Sister's Cafe, My Sister's House helps victims to find jobs through its Women to Work program. This program provides information, support and resources to survivors in order to work towards becoming financially independent. The organization's employment advocate provides direct services and manages the cases of clients that are enrolled in the program.

"Our employment advocate on staff assists clients with developing resumes, conducting job searches and preparing for job interviews," said Valmores. "My Sister's House also conducts mock interviews to strengthen clients' confidence in their job search."

My Sister's House welcomes volunteers, donations and community support year round. However, as the new year rolls around, the generosity of donors,

sponsors and helpers is certainly appreciated.

"I hope that every day we offer love, friendship and support to those who use our services," Valmores said. "During the holiday season, thanks to the generosity of donors, there are more calories and delicious treats to feed our clients and more spoiling that is occurring."

Although there are several local groups that work to help out those in need in the community, My Sister's House specializes in assisting Asian and Pacific Islanders. These groups regularly experience these unfortunate crimes, but tend to be poorly represented culturally and therefore often don't receive the help that is needed.

"I hope that people know that there are unfortunately high rates of domestic violence, sexual assault, and human trafficking within the Asian and Pacific Islander community - made even higher if one factors in the suspected high unreported rate," Valmores said. "One's trauma experience often begins with one's culture, so the healing responsive must be culturally based too, which is what My Sister's House seeks to do."

the two were picked up by Border Patrol agents and separated.

The father was deported, but it took weeks before the parents knew where Eduardo was taken. He spent four months in detention, turning 12 alone at a facility in Brownsville, Texas. The once-affectionate boy returned home angry in September. He rarely goes out, spending most of his time in his room watching TV. He's refused to go to school and will have to repeat the sixth grade. He talks back to his parents and hits his little sister, whom he used to be close to. The family doesn't know what to do to help him.

"This was the toughest year of all," said 38-year-old Meyer.

Polling finds a big majority of Americans still view the country's openness to immigrants as essential to the nation's identity. But the profound shift in government policies on the subject threatens that idea of the U.S. as a welcoming land of opportunity for all.

Christina Greer, a political science professor at Fordham University, sees Trump's immigration overhaul as the continuation of a tug-of-war that's played out since the nation's founding, between what many see as bedrock American ideals and a pattern of nevertheless being hostile to newcomers.

"The country, unfortunately, has had an incongruence with the myth of America versus the reality of America," said Greer, who authored "Black Ethnic:

Race, Immigration, and the Pursuit of the American Dream."

"Trump's really fine with blowing up the myth."

Sharry thinks the country's reputation suffers when its leaders close the doors to others: "They've put a million people on the road to deportation. They've ripped thousands of kids from their parents. They've gutted refugee protection at our border. They're building and expanding detention centers. They're trying to scare low-income immigrants from using health and other services. They've taken aim at legal immigration. They've slashed refugee admissions. That's a pretty relentless assault on a core principal of the American experiment."

Others see it far differently.

Neil Gouveia came to the U.S. from Guyana as a 7-year-old. His family waited years to earn visas, then waited again to become citizens. His parents made the difficult choice to leave behind his 9-year-old sister, who had cerebral palsy and wasn't granted a visa.

Gouveia considered himself a typical "liberal New Yorker" until 2016, when he was drawn to Trump for what he believed was his strength on national security. Gouveia is gay and said the mass shooting at a gay nightclub in Orlando, Fla., particularly shook him.

He wasn't offended when Trump referred to parts of the world as "s—hole countries," and doesn't see anything inherently wrong in separating immigrant children from the adults they arrive with. He thinks, ultimately, it will all lead to greater dialogue and better policies. And he still believes America stands

as a beacon for much of the world.

"At the end of the day, people will say what they want to say about America, but there's hardly anyone who still wouldn't want to come here," said Gouveia, 39, a collegiate fundraiser. "They still know it's like winning the lottery."

Daniel Stein heads the Federation for American Immigration Reform, which supports restrictive immigration measures. He agrees the year's immigration imagery has had "a huge political impact on the psyche of the nation," but argues it has moved more people to his side of the debate. And to those who see the year as an extended assault on a cornerstone American value, he's unmoved.

"They have a vivid imagination," Stein said. "We have one of the world's most generous immigration programs."

That's little comfort to Buena Ventura Martin Godinez, a 29-year-old mother of two who carried her 9-month-old son across the border in May, fleeing threats from violent gangsters in her

hometown of San Juan Atitan, Guatemala. She was caught in Arizona and held for a week at a detention center with her baby. When her husband followed two weeks later with their 7-year-old daughter, they weren't so lucky.

The girl was sent to a facility in Michigan and kept there for six weeks; the father went to an Atlanta jail, where he still awaits deportation. Her family fractured, Godinez now regrets the day she ever headed to the U.S.

"I came looking for a better life ... and everything went wrong," she said from the five-room house in Homestead, Fla., that she and her two children share with nine others. "I thought that it was true that it is a country that gives opportunities. But it is not."

Godinez notices changes in her children. Her daughter, always so sweet and obedient, cries incessantly and struggles in school. Her son keeps falling ill, his temperament now trademarked by screaming, crying and sighing.

"This is the worst year I ever had," she said.

Raffi Stepanian spends his time on all fours in the street with tweezers looking for specks of gold, silver and jewels that have fallen off clothing and jewelry in the city's Diamond District. He told the New York Post that he'd recently earned \$819 in redemptions for six days of prospecting.

Your job hunt can be paved with gold, too, if you listen to Dick Bolles' advice. He is the author of what I think is the greatest career book ever, "What Color is Your Parachute?" (Ten Speed Press). It's a 40-year-young guide for all things ca-

reer. The following three Do's and one Don't should help you adjust to the new realities of looking for work.

- **DON'T** live in the past. Anyone who has found at least one job successfully has a series of strategies that they believe will work for them next time they need a job. The only problem is that the world is changing, and you've got to adapt. Online networking, using social media, bringing work samples to an interview, talking with competitors – today you've got to bring a host of new strategies to your job hunt. Sure, you can do what's worked before, but you also need to add a few new strategies.

- **DO** change attitude. Would you hire someone who walks into your office trailing blood

and bile? Of course not; you want to hire someone who is energetic, creative and ready to hit the ground running. That's why it's so important to start with your attitude. No matter how cynical and beaten up you feel from having lost your last job, you've got to try to bring new energy and enthusiasm into your job hunt. Volunteer, exercise or use hobbies to build your confidence.

- **DO** take inventory. I can't tell you how many people I've met who hate their current job or profession. That's why Bolles' insight is so valuable: We all need to be constantly taking inventory of not only our skills, but also our enthusiasm. Just because we can do a job doesn't mean that we'll be happy doing

it. And with the changing job market, you just might be surprised to see how combining your skills in a new way opens up doors that you didn't even realize existed.

- **DO** up your game. So many people think that getting a job is totally based on what you've done in the past. Nothing could be further from the truth today. The key to getting hired is showing potential employers what you'll be able to do for them in the future. Outline how you'll solve their most challenging issues and you'll get their attention.

Follow these tips and you'll be counting your gold, too – not from the street but from your new paycheck.

including a funeral that featured a who's who list of entertainers, former presidents and prominent preachers.

Others from the world of entertainment who died in 2018 included the two men who created one of the most popular and enduring superheroes of the modern day. Marvel Comics icon Stan Lee, who died in November, and artist Steve Ditko, who died in June, gave the world the web-swinging Spider-Man along with a host of other super-powered heroes. Author Tom Wolfe, playwright Neil Simon, actor Burt Reynolds and screenwriter William Goldman also died.

And one of the world's most influential scientists died in 2018. Though his body was paralyzed by disease, theoretical physicist Stephen Hawking explained the mysteries of space, time and black holes to a generation of enthusiasts.

Here is a roll call of some of the people who died in 2018. (Cause of death cited for younger people, if available.)

JANUARY

Thomas S. Monson, 90. He was considered a prophet by nearly 16 million Mormons worldwide and spent nearly a decade as church president. Jan. 2.

John Young, 87. The legendary astronaut who walked on the moon and later commanded the first space shuttle flight. Jan. 5.

France Gall, 70. A French pop singer who shot to fame in the 1960s by winning the Eurovision Song Contest then produced hits and sold millions of albums over a four-decade career. Jan. 7.

Doreen Tracey, 74. A former child star who played one of the original cute-as-a-button Mouseketeers on "The Mickey Mouse Club" in the 1950s. Jan. 10.

Edgar Ray Killen, 92. A former Ku Klux Klan leader who was convicted in the 1964 'Mississippi Burning' slayings of three civil rights workers. Jan. 11. Died in prison.

John V. Tunney, 83. His successful campaign for a California seat in the U.S. Senate became the basis for the 1972 Robert Redford film "The Candidate." Jan. 12.

Keith Jackson, 89. His signature phrases like "Whoa, Nelly!" made him the down-home voice of college football during more than five decades as a sportscaster. Jan. 12.

Dolores O'Riordan, 46. Her urgent, powerful voice helped make Irish rock band The Cranberries a global success in the 1990s. Jan. 15.

Edwin Hawkins, 74. The gospel star best known for the crossover hit "Oh Happy Day" and as a major force for contemporary inspirational music. Jan.

15.

Stansfield A. Turner, 94. He served as CIA director under President Jimmy Carter and oversaw reforms at the agency after the Senate uncovered CIA surveillance aimed at American citizens. Jan. 18.

Ed Moses, 91. The prolific abstract expressionist who was one of the founding members of a collective known as the "Cool School" and helped transform Los Angeles from a cultural backwater to a major force in the world of modern art. Jan. 17.

Dorothy Malone, 93. An actress who won hearts of 1960s television viewers as the long-suffering mother in the nighttime soap "Peyton Place." Jan. 19.

Olivia Cole, 75. She won an Emmy Award for her portrayal of Matilda, wife to Chicken George in the landmark miniseries "Roots." Jan. 19.

Paul Bocuse, 91. The master chef who defined French cuisine for more than half a century and put it on tables around the world. Jan. 20.

John Coleman, 83. He co-founded The Weather Channel and was the original meteorologist on ABC's "Good Morning America" during a six-decade broadcasting career but who later drew people's anger for his open skepticism about climate change being man-made. Jan. 20.

Ursula K. Le Guin, 88. The award-winning science fiction and fantasy writer who explored feminist themes and was best known for her Earthsea books. Jan. 22.

Ingvar Kamprad, 91. As founder of IKEA, he turned a small-scale mail order business started on his family's farm into a furniture empire by letting customers piece together his simple and inexpensive furniture themselves. Jan. 27.

Mort Walker, 94. A comic strip artist and World War II veteran who satirized the Army and tickled millions of newspaper readers with the antics of the lazy private "Beetle Bailey." Jan. 27.

FEBRUARY

Dennis Edwards, 74. A Grammy-winning former member of the famed Motown group The Temptations. Feb. 1.

John Mahoney, 77. An actor who played the cranky, blue-collar dad in the TV show "Frasier." Feb. 4.

Jim Bridwell, 73. A hard-partying hippie and legendary climber who lived his life vertically on some of the toughest peaks in Yosemite National Park. Feb. 16.

The Rev. Billy Graham, 99. He transformed American religious life through his preaching and activism, becoming a counselor to presidents and the most widely heard Christian evangelist in history. Feb. 21.

Nanette Fabray, 97. The vivacious actress, singer and dancer who became a star in Broadway musicals, on television as Sid Caesar's comic foil and in such hit movies as "The Band Wagon." Feb. 22.

Sridevi, 54. Bollywood's leading lady of the 1980s and '90s who redefined stardom for actresses in India. Feb. 24. Cardiac arrest. Accidental drowning in a bathtub.

Harvey Schmidt, 88. The composer of "The Fantasticks," which made its debut when Dwight D. Eisenhower was still president and became the longest running musical in history. Feb. 28.

William Henry Trotter Bush, 79. A wealthy investor and the brother and uncle of presidents. Feb. 28.

MARCH

Roger Bannister, 88. He was the first runner to break the 4-minute barrier in the mile. March 3.

Russell Solomon, 92. The founder of the Tower Records chain that became a global phenomenon and changed the way people consumed music. March 4.

George Sinner, 89. The farmer-philosopher who served as North Dakota's governor during one of the state's roughest economic times. March 9.

T. Berry Brazelton, 99. He was one of the world's most well-known pediatricians and child development experts whose work helped explain what makes kids tick. March 13.

Stephen Hawking, 76. A theoretical physicist whose brilliant mind ranged across time and space though his body was paralyzed by ALS. March 14.

David S. Wyman, 89. A leading scholar of the U.S. response to the Holocaust whose "The Abandonment of the Jews" was a provocative, best-selling critique of everyone from religious leaders to President Franklin Roosevelt. March 14.

Peter G. Peterson, 91. A billionaire and business executive who became

one of the most prominent voices to argue for entitlement reform and reducing the U.S. national debt. March 20.

Frank Avruch, 89. A longtime Boston television personality and entertainer who was the star of the popular children's TV program "Bozo the Clown." March 20. Heart disease.

Rusty Staub, 73. The orange-haired outfielder who became a huge hit with baseball fans in two countries during an All-Star career that spanned 23 major league seasons. March 29.

Anita Shreve, 71. The best-selling novelist who explored how women responded to crises past and present in her native New England in favorites such as "The Pilot's Wife," "Testimony" and "The Weight of Water." March 29.

If you think today's political insults are nasty, consider these mud bombs hurled at Presidents Ulysses S. Grant, Franklin Pierce and Grover Cleveland, respectively: "A drunken trowser-maker!" "The pimp of the White House!" "A moral leper!" John Adams was called "a blind, bald, crippled, toothless man who is a hideous hermaphroditic character."

But some of the most potent POTUS potshots have been more crafty than crude. Pundits who thought John F. Kennedy was all image and no substance urged him to show "less profile and more courage." The inspiration for this line, a clever allusion to Kennedy's book "Profiles in Courage," came from Eleanor Roosevelt, who slyly advised Kennedy, "When blows are rained on one, it is advisable to turn the other profile."

Critics of Harry F. Truman drew on both low and high culture, cunningly revising the pop song lyric "I'm just wild about Harry" to "I'm just mild about Harry," and the famed epigram of British essayist Alexander Pope from "To err is human" to "To err is Truman."

U.S. Representative John Sherman, a Republican from

Ohio, snarked at Democratic President James Buchanan, "The Constitution provides for every contingency in the Executive, except a vacancy in the mind of the President."

Alleging a similar cranial vacuum, U.S. Congressman Barney Frank remarked, "People might cite George W. Bush as proof that you can be totally impervious to the effects of a Harvard and Yale education."


And don't forget those presidential nicknames, e.g., "Useless Grant," "Rutherford" B. Hayes and "President Hardly" (Warren G. Harding).
