MY SISTER’S HOUSE UNIQUE CHALLENGE

A SAFE HAVEN

For almost 20 years, My Sister’s House has provided a culturally appropriate safe haven for Asian and Pacific Islander survivors of domestic, sexual violence, and human trafficking in Sacramento and the Central Valley. My Sister’s House programs include an emergency shelter where clients of all ethnicities can stay for up to 90 days and a Women-to-Work program that helps survivors become self-sufficient.

OUR UNIQUE CHALLENGE

Traditional Asian and Pacific Islander values and norms are at times also cultural barriers, making it difficult for Asian and Pacific Islander survivors of sexual assault or domestic violence to disclose, report, or seek services. In addition, many Southeast Asians come from families who came to the U.S. as refugees, fleeing from war in their native countries of Vietnam, Laos, or Cambodia.

Cultural barriers are among the largest barriers to accessing services, including language, immigration concerns, and stigma. My Sister's House addresses these barriers with our depth of experience working with and serving the Asian and Pacific Islander community and by offering culturally relevant and in-language services.

SUPPORTING SURVIVORS

MISSION

To serve Asian and Pacific Islander and other underserved women and children impacted by domestic violence, sexual assault, and human trafficking by providing a culturally appropriate and responsive safe haven, job training, and community services.

HOLISTIC HEALING

To achieve our mission, My Sister's House provides survivors with holistic support that ensures the women and their children have a foundation for self-sufficiency and a life free of abuse.



OUR PROGRAMS

OUTREACH AND EDUCATION

Helps prevent domestic violence, sexual assault, and human trafficking by providing training and education to students of all ages, workplaces, churches, and other social settings.

24/7 MULTI-LINGUAL SUPPORT LINE

Assists callers to identify the signs of domestic violence and human trafficking, crisis intervention, safety planning, information and resource referrals and general support.

SAFE HAVEN SHELTER

My Sister's House is the only shelter specifically serving the needs of the highly diverse Asian and Pacific Islander population in Sacramento and the Central Valley region. It provides a much-needed place for women and children fleeing domestic violence, sexual assault, and human trafficking. Clients of all ethnicities can stay at the shelter for up to 90 days and receive food and supplies, case management, and support.

WOMEN-TO-WORK

Our unique program helps survivors of domestic violence, sexual assault, and human trafficking get back on their feet, especially financially. Support groups provide information and resources to survivors free of charge. Counseling Sessions are facilitated and/or supervised by licensed marriage and family therapists. These sessions include weekly Domestic Violence Education, Healing Through Art, Parenting Classes, and a #MeToo Sexual Assault Survivor Support Group. The Women to Work program provides an array of supportive services — healthcare information and referrals, transportation, clothing, child care, housing assistance, employment/career guidance, legal services and more — helping clients achieve a state of stability.

OUR CAMPAIGN PRIORITIES

My Sister's House relies on contributions from individuals, foundations and corporations to offer impactful life-changing services and programs. Contributions will support areas in which we see growing needs for survivor resources, especially in the following priorities:

SAFE HAVEN

My Sister's House plans to expand and acquire property to accommodate an increasing number of diverse women and families who seek our support. Recently, with initial support from SMUD and key donors, My Sister's House initiated a drive to raise funds for the Noor House, the first domestic violence emergency shelter for Muslim women in the Central Valley. In addition, as our shelters—or our safe havens—age, we seek funds to provide for continuous upgrades of our facilities and have sufficient funds for renovation, maintenance, and one-time improvements.

LEGAL SERVICES

In 2019, 100+ Asian and Pacific Islander women gathered in Sacramento to identify community needs. In particular, one need was repeatedly mentioned: the need for more culturally appropriate domestic violence legal services.

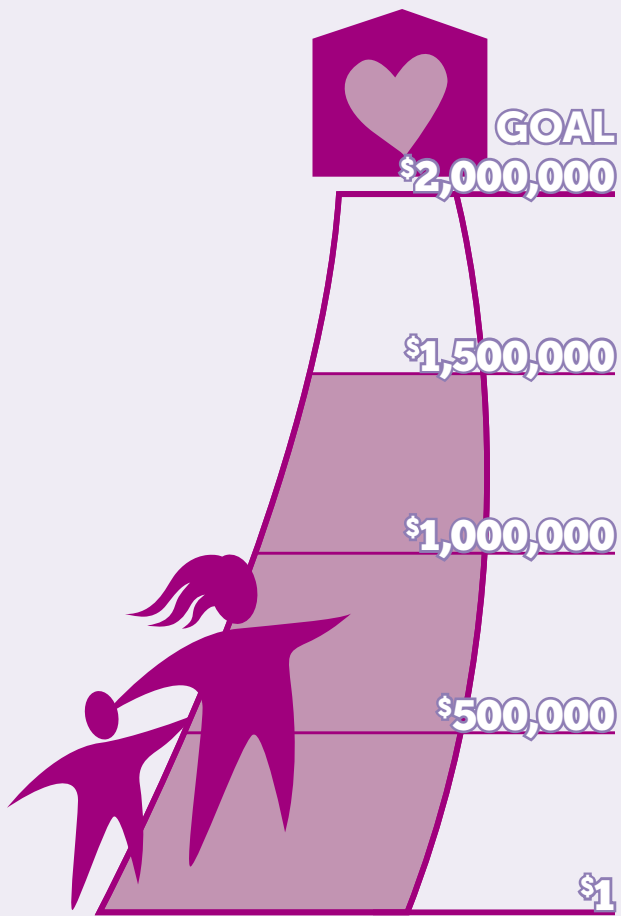
My Sister's House addresses this need and seeks to expand our capacity to do so— through a three pronged approach that is justice-, community-, and individually- based. Our legal services include online chat and phone lines for legal advice, direct services (in-language appointments and legal clinics.), and outreach and education to community members.

MY SISTER'S TREASURES (SECOND SOCIAL ENTERPRISE)

With the success of My Sister's Cafe and our Women-to-Work program, we have plans underway to establish a second social enterprise, a high-end thrift store that provides skill-building opportunities such as retail training and management to help survivors "get back on their feet" and achieve self-sufficiency. With support from an advisory committee, we have conducted a feasibility study, considered skills and training opportunities for survivors, identified potential store locations, and brainstormed marketing ideas.

ESTABLISHING AN ENDOWMENT FOR MY SISTER'S HOUSE.

Every organization should have a rainy day fund to cover emergencies or unexpected changes. My Sister's House is seeking to establish an emergency fund also as part of its 20th Anniversary campaign.
